Modification Details

Purpose: This modification is issued to add clauses by reference to Section I and move a clause in Section H.

Modification:

1. In Section I add the following clauses by reference:

FAR 52.204-19 Incorporation by Reference of Representations and Certifications (DEC 2014)
FAR 52.209-10 Prohibition on Contracting with Inverted Domestic Corporations (DEC 2014)
DFARS 252.204-7005 Oral Attestation of Security Responsibilities (Nov 2001)

2. In Section H, Paragraph H.9 is changed back to RESERVED and the Clause that was at H.9 entitled "CONTRACTOR RESPONSIBILITY REGARDING PORTAL ACCOUNTS" (added in the 2014 Rolling Admissions changes modification) is moved to the a newly added paragraph H.22. Therefore, H.22 is added as follows:

H.22 CONTRACTOR RESPONSIBILITY REGARDING PORTAL ACCOUNTS

It is the responsibility of the Contractor to maintain active account(s) in the portal to be able to receive all notices and modifications. Account holders are required to log in to the portal at least once every thirty (30) days or their accounts will become inactive. Inactive accounts do not receive notices from the portal including requests of information, solicitation release notices, award notices, bilateral modification notices and other communications. The portal is the sole method the Government utilizes to correspond with MAC holders so it is imperative that all the respective account holders maintain active accounts.

3. Update all clauses in contract to latest revision date as of 30 April 2015.

4. All other terms and conditions remain unchanged and in full force and effect.
